

Spudshed Year of the Tiger Colouring Competition

Terms and Conditions of Entry

1. The promoter is Vegie Bandits Pty Ltd (ACN 079 441 044) trading as Spudshed (ABN 31 079 441 044) (**Spudshed**).
2. Information on prizes and how to enter form part of these Terms and Conditions of Entry (**T&CE**).
3. By entering this competition entrants agree to be bound by these T&CE.
4. Entry is open to all West Australian residents aged up to 12 years old, excluding employees, suppliers and their immediate family members of Spudshed or any related entities (**Eligible Persons**).

How to enter

8. Entrants must:
 1. Collect a Year of the Tiger Colouring Competition sheet from the Spudshed store service desk
 2. Colour in the competition sheet
 4. Complete their details on the Competition Sheet
 5. Drop their completed Colouring Competition Sheet to the Spudshed store service desk
