

Spudshed 'Aussie Gumnuts Colouring Competition'

Terms and Conditions of Entry

1. The promoter is Vegie Bandits Pty Ltd (ACN 079 441 044) trading as Spudshed (ABN 31 079 441 044) (**Spudshed**).
2. Information on prizes and how to enter form part of these Terms and Conditions of Entry (**T&CE**).
3. By entering this competition entrants agree to be bound by these T&CE.
4. Entry is open to all Western Australian residents aged 12 years and under, excluding supplier, employees and/or any related family members of employees of Spudshed or any related entities (**Eligible Persons**).
5. Spudshed 'Aussie Gumnuts Colouring' Competition 2022 (**Competition**) runs from 09:00am (AWST) on Thursday 7 July 2022 to Midnight (AWST) on Sunday 17 July 2022 (**Promotion Period**).
6. Winners will receive a set of 8 Aussie Gumnuts Children's Books valued at \$127.92 (**Prize**).
7. There will be five winners drawn per Spudshed store which will be chosen from the Eligible Entries received at each Spudshed store.
8. The Winners will be drawn and contacted between 08:00 (AWDT) on Monday 18 July 2022 and 17:00 (AWDT) on Tuesday 19 July 2022.

How to enter

9. To qualify as an Eligible Entry entrants must during the Promotion Period:
 - a. colour-in and complete the fields on the Colouring Competition Sheet Entry Form (**Entry Form**); and
 - b. hand the completed Entry Form to the staff member at the service desk at one of the Spudshed stores.
10. Entrants can only enter the Competition once during the Promotion Period.
11. Entrants must obtain parental or guardian consent to enter the competition.
12. Entrants who provide incorrect, misleading or fraudulent information are ineligible to participate in the Competition and all entries of an entrant who is deemed by Spudshed to have provided incorrect or misleading information may, at the discretion of Spudshed be deemed invalid.
13. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

20. By completing the Entry Form, entrants' consent to receive future Spudshed promotional and/or marketing materials, including weekly specials.
